Completing this form electronically:

You can either complete this form electronically, or you can print it out and fill it in by hand. Notes on applying for a mooring

1. Completing this Application Form **only registers your interest** in obtaining a NEW mooring **specifically** in the Dale Voluntary Controlled Area of the Milford Haven Waterway for the year ending 31 March 2026.
2. There are two licences applicable for each mooring: **Milford Haven Port Authority Licence** and **Crown Estate Licence**.
3. **Milford Haven Port Authority Licences – you need to indicate which type of licence you require:**

A **Private Licence** allows the licence holder to moor a **single, named, recreational vessel (private pleasure craft)** within the Milford Haven Waterway.

- Private Licences incur a fee on **first application only**; subsequent annual renewals do not incur a fee.
- If you have **more than one Private Licence** in the Milford Haven Waterway then you pay a licence fee **each** year for **each** Private Licence (mooring).
- **A change of vessel** associated with the Private Licence (mooring) **will require relicensing** and payment of the appropriate fee.

Private Licence Fees for 2025 are:

Price	Vessel Length Overall (LOA)
£63	< 5.5m (18ft)
£91	> 5.5m to < 7.5m (24.5ft)
£129	> 7.5m to < 12m (39.4ft)
For vessels over 12m (39.4ft) LOA add £10.50 per metre or part meter	

All prices are inclusive of VAT at 20%.

OR: A **Block Licence** is required if:

- a) **more than one vessel** is to use the mooring, or
 - b) the mooring is to be used by a **commercial vessel**.
- For Block Licences, as in item 1 above, please state the dimensions of the largest vessel that will use the mooring.
 - Block Licences incur a licence fee **each** year.
 - The Block Licence Fee for 2025 is **£159 incl. VAT** for vessels < 15m (49ft) LOA. **Vessels over 15m are not permitted in the Dale Voluntary Controlled Area.**

4. Crown Estate Licences:

The cost for the 2025 annual licence from the Crown Estate, for rental of the seabed, will be **£96 incl. VAT**. This fee applies to **all** types of moorings and is payable **each** year.

5. **Do not make any payment at this stage. This is an application only. Payment will be taken when a mooring offer is accepted.**

6. Offers of mooring sites are made on the basis that the information provided on this form is correct. Incorrect or out of date information may result in an offer being revised or possibly rescinded on receipt of the actual mooring licence application.
7. All vessels moored within the Milford Haven Waterway are required to abide by the conditions of the licence, Milford Haven Port Authority Byelaws and General Directions. Breaches may result in licences being revoked.
8. Mooring gear is not supplied or maintained by either Dale Voluntary Controlled Body or by Milford Haven Port Authority. It is the responsibility of the licence holder to lay and maintain their mooring gear (use of a reputable contractor is advised).
9. A mooring site is licensed to a **person and their named vessel** and is **not transferable** to another person, for example on the sale of the vessel. However, in such cases, it **may** be possible for Dale Voluntary Controlled Body to allocate an appropriate site, depending on the state of the waiting list.
